3) Treasurer's Report - Carolyn Aarup:

Budget Update: AMHA: \$2073.43 Regular: \$6,829.58 AMHR: \$3,998.52 US Acct: \$685.03

Carolyn A: excited to announce that after many years of persistent requests to bank, she was able to get MHCO bank accounts on line! This will help future Treasurer get easy access to bank statements rather than waiting for snail mail statements. Anne Savage: ETransfer for the Classic show was very favorable and this method of payment was ideal. Carolyn A. will investigate further to see if members can etransfer payments directly to the MHCO.

Carolyn A: NSF Cheques will need to have a penalty charged back to the member, as banks will auto charge this fee to the Club. Motion by Carolyn A.: The MHCO will charge a NSF fee of \$25 to cover applicable bank charges. This fee is to be reviewed yearly at each Fall AGM to ensure adequate fee coverage. 2nd by: Bev Beesley None Opposed -carried

Motion for Caroline M.: Carolyn A. to be refunded \$7.00 as payment for a former NSF cheque Fee. 2nd by: Cathy Fisher None opposed. -carried

5) Point Club Shows - Doug Savage, Angie Trumpler:

- 5.1 Rule Reminder: Conduct of Exhibitors was reviewed by Doug. (ie: No hitting your horse with the end of a lead and no physical violence to be directed towards the horse at any time.)
- 5.2 Review of the 5 Point Shows to the Membership and a reminder that any new shows added would have to be self-sufficient. (Meaning at no cost to the Club) Host Show package is on the MHCO site under Downloads page under Host Shows
- 5.3 Thank you to the Volunteers who give a hand at the shows with set-up and tear down
- 5.4 Sarah McNeil: Can the obstacle class be moved before lunch? Unfortunately no. In the past we ran this format and if the show runs late, then it is a Safety Hazard to drive when it is getting dark. (It is safer to perform obstacle in hand during this time of day.)
- 5.5 Review of the Honour Roll program by Carolyn A. (Please refer to website on Downloads page under Awards for more info.)
- 5.6 Are their any volunteers for the Point Show Secretary position? –No
- 5.7 Bev Beesley: Motion that Anne Savage be retained as the 2017 Club Secretary. 2nd Wendy Eagle None opposed. –carried

Awards - Caroline Moor:

- 6.1. The trophies this year cost: \$10.50/small trophy, \$17.95/large trophies, \$5.75/plates, \$41 Sash = \$870.61 (\$690.51 was the Club cost after keeper award \$ was collected from the Sponsors.) –For 2017 there might be a fee increase on the keeper awards of \$25 to the Sponsors
- 6.2. HighPoint yet again were our Trophy Suppliers. They are fabulous to work with, very accommodating and their pricing is excellent
- 6.3. The trophy budget is \$1,500, so the Club did very well with staying well under budget.

7) AMHR Sanctioned Show – Doug Savage:

- 7.1 62 horses in attendance in 2016
- 7.2 2017 class fees will be the same as 2016 new show date on MHCO website
- 7.3 Currently the committee is working on making Judge/Stewart selections
- 7.4 2017 fee for QuarDreams will be \$475 (increase of \$25 from this year.)
- 7.5 Class list will be the same in 2017 as it was this year
- 7.6 Marie Krawcyk: Can Jumper be added (in addition to Hunter) for 2017. Both A&B sections would need to be added. —To be discussed by the Committee
- 7.7 The show came out on a profit. Income \$6,440.25 expenses: \$4,722.12 Profit: \$1,718,13 See AMHR Classic's Sanction Show Financial Report Attached Appendix# B

- 11.2 Please note you need to be a Member (in good standing,) to volunteer at any Promotional Event. (ie your Membership must be paid in full well in advance (January 1) BEFORE the event takes place.)
- 11.3 The Fergus Legion has been booked for 2017 for both the Spring/Fall AGM's
- 11.4 \$288 was raised today for the AMHA fundraiser in Quilt ticket sales. (Thank you Frannie Filipowicz for the donation of your beautiful quilt!)

11.5 Fundraising Committee -

- Please don't forget that we are a nonprofit organization and running fund raisers like the silent auction table we enjoyed today goes a long way to fund our Clubs activities. (It is an easy and effective way to raise substantial funds!)
- Darrin Dennis: What about 50/50 draws? Doug: We certainly can do this and have done it limited in the past, but these types of fundraisers need volunteer support. (Darrin has offered his assistance with running this draw.)
- New Member Nancy Cohen: She sells a product called "head of the herd" that she retails for \$19.95 She will sell to Clubs for \$10 & Clubs use this as a fund raiser (making \$10/bottle.) Nancy will take back any product that is not sold. Reminder: The MHCO cannot sell merchandise at any promotional event. This could only be sold at Mtg's & the Fuzzy Show. The MHCO will work with Nancy and set-up a display at the Fuzzy Show as a fundraiser.
- What about tack swaps? We have held a swap at the Fuzzy Show. We could charge the Membership a table fee. Or we can run it free of charge as a service to our membership
- Carolyn A: 2016 Driving Clinic: 29ppl @ \$25/each. 5 horses participated @ \$75/each. Profit: \$999.50 to the Club.
- In 2017 we will be holding an advanced driving clinic using an outside clinician on Aug. 20th at QuarDreams. (The day after the Savagemoor show @ QuarDreams) This clinic will also be open for Auditors to attend.
- The committee will investigate holding a beginner driving clinic again in 2017, as per requested by the Membership

12) A & P - Carolyn Aarup:

- 12.1 Carolyn A: The Rider Magazine (Kelly Bowers,) has offered the MHCO an ad space in their paper at a reduced fee of \$59 x2 for a business card sized add. MHCO will go forward and pay for this advertising. Raquel: It was suggested as per our club mandate that more "public" promotion is needed like booths at trade shows etc if club can afford it
- 12.2 The budget is \$900/year for advertising.
- 12.3 2017 Grey/Bruce Farmers Week will also be supported by the MHCO. (No fee to attend)
- 12.4 Wendy Eagle: March 3-4th Central Ontario Ag. Conference (Georgian College in Barrie,) will also include backyard/small scale farming, as well Equine Specialists will be in attendance on the Saturday. Equine Mania will also be in attendance. \$250 fee for Clubs to attend (Have a display table and includes 1 free attendance ticket.) \$35 fee for attendees. Anne Savage: Would the Club pay for the Youth to attend? –Yes (Volunteers to attend will be: Bev Beesley and Faith Dennis) 18 "Show of hands" were counted from the Membership shows support for the MHCO to attend. -2 Opposed

- 12.5 Horse Illustrated (USA) has contacted the MHCO for advertising, but the cost is several hundred dollars and not worth the price to advertise in a US magazine
- 12.6 Julie Chronicle Update on sales: All copies were sold and the Club returned a profit on this fundraiser. Unfortunately the chronicle cannot be turned into a digital format for purchase.
- 12.7 \$802 funds were raised today towards the silent auction table deposit split \$402 each to MHCO Reg Account and AMHR Classics Sanctioned show Account
- 12.8 Julie: Cook books \$280.52 raised to date and are still available @ \$12/each
- 12.9 Julie: AMHR Journal Ads: \$75 to receive promotion in 6 Journals, under the MHCO full page ad. To date we have 5 paid ads. Carolyn A asked Julie to prepare another email to send out to members again

13) New Business – Doug Savage:

13.1 There will be an Insurance increase for 2017 of 3%. MHCO Insurance is through InterCity, who offers the MHCO a drastically reduced rate based on other providers. Our Insurance also includes Director coverage insurance.

14) Old Business – Doug Savage:

- 1.1. 14.1. Doug: Currently at the MHCO the jumping courses do not have a change of diagonal. This year we had questions by AMHR Judges asking why we don't do this. So for 2017, we will re-instate this change.
- 1.2. Laurie Green: Review the requirement to attend 3 points shows out of the series of 5 shows. Laurie explained that her sponsored trophy (Perpetual Youth Driving) has not been handed out for the last 2 years due to the Youth Drivers driving in less than the required 60% of club shows. Discussion within the Membership was held on this topic without any resolvement. This topic will be added onto the Agenda of the 2017 Spring AGM for further discussion.
