\*\*\*\* At the spring meeting, the proceeds from the raffle were to go towards the Club Shows (in particular, the additional fee for John Wills to judge at Orangeville). The total received was \$89.00. So that brings the overall loss to \$110 (compared to 2017 \$660 loss).

However, ticket sales on the donated quilt are to go towards the Club Points Shows so the deficit will actually be erased and we will have a profit!
